## Craft Show Guidelines

**Date:** Saturday, December 4, 2010

**Time:** 8:00 a.m. to 4:00 p.m.

**Craft Show Location:** Inside Dauntless Fire Station & VFW (1<sup>st</sup> & 2<sup>nd</sup> Floors)  
Downtown Ebensburg  
19 miles north of the City of Johnstown  
24 miles west of the City of Altoona  
74 miles east of Pittsburgh  
140 miles west of Harrisburg

**Show Format:** Once again this year, all aspects of the event will follow a Dickens-style theme. All craft booths choosing to be part of the craft show **MUST** feature handmade items only. The overall event is to maintain a Dickens theme. All vendors must have something Victorian (decorations, etc.) associated with their booth. We also encourage all to dress up, even with something as small as a scarf or Victorian-style hat.

This is not an event for cotton candy, pop guns, sports cards, silly string, beanie babies and other such items normally found at street carnivals. The atmosphere is to maintain a Victorian theme and vendors are encouraged to dress up.

**Space Size:** We will supply each vendor with one 8' table & 2 chairs per space.

\*If in the firehall, approximately four additional feet will be behind your chairs and two feet in between tables. (Total space size is approx. 8' x 8')

\*If in the VFW, there is very little space behind your chairs and about a foot in between tables. (Total space size is approx. 3' x 8')

**Fee Per Space:** \$30.00

**Set-Up:** Friday 6:00 p.m. to 8:00 p.m. and/or Saturday 7:00 a.m. to 8:00 a.m.

**Teardown:** 4:00 p.m. – 6:00 p.m.

**Electricity:** Not provided (If you absolutely need electricity for your booth display, please notify us and we will do our best to place you near a plug)

**Registration Deadline: September 17, 2010**

### Rules & Regulations:

- All vendors are strongly encouraged to dress in Dickens-style period costume of the Victorian era. Ideas are provided on our website at [www.EbensburgDickens.com](http://www.EbensburgDickens.com)!

- No refunds after September 1, 2010.
- No vans or vehicles will be permitted on the street or sidewalk during the festival.
- To facilitate traffic flow during set-up, all vendors must unload their goods and drop them into their assigned space as quickly as possible, and remove their vehicle from the front of the fire station **before** setting up! At the end of the event, booths must be dismantled and ready to load **before** vehicles are brought to the fire station.
- Exhibitors are responsible for their own trash removal. Please leave the area as clean as you found it.
- All applications are reviewed on a first-come first-serve basis! No changing or swapping of spaces will be allowed. Spaces may not be shared with any non-applicant.
- Failure to notify the Dickens committee of a cancellation in advance will affect future participation.
- Locations will be locked between 9:00 p.m. Friday and 7:00 a.m. Saturday for security.
- All vendors must be out of the fire hall and VFW by 6:00 p.m. on Saturday.
